On August 27, 2025, the TCA Board of Directors met and dealt with the issue of the ballot sent to the membership on August 15th. Two significant motions were adopted.

First, A motion was made "that the ill-conceived, poorly constructed and highly confusing ballot that was sent out on August 15, 2025, be and it is hereby immediately rescinded, nullified, terminated, and shall have no further effect."

The motion was seconded. The vote was 17 yes and 2 no. The motion passed.

A second motion was made "that the President, the Officers, the members of the Board of Directors, the entire staff of the Train Collectors Association (TCA) be, and they are hereby directed to immediately cease any and all efforts, communications or discussions pertaining to or in any way related to selling leasing, mortgaging any property of the TCA, including, without limitation any and all real and personal property or any fixed assets.

The motion was seconded. The vote was 16 yes, 1 no and 2 abstentions.

After these 2 motions passed, the Board of Directors felt that a letter should go out to the TCA members explaining the ballot situation. As your Dixie Division President, below is the letter that the majority of the BOD approved to be sent to the TCA members:

On August 27, 2025, your TCA Board of Directors met and dealt with the issue of the ballot sent to the membership on August 15th. This ballot was sent out prematurely, which is unfortunate, and was rescinded by an overwhelming vote.

Rest assured your TCA Board of Directors are responsible for anything that resembles sales or offers for any TCA Properties. We have a Fiduciary Responsibility to the TCA Membership and the Commonwealth of Pennsylvania which includes "due diligence" to all members.

In the near future, the TCA BOD will be dealing with other internal issues, including financial transparency that you requested regarding the museum property. Please, rest assured, that our wonderful club is in a very good financial position.

In the coming weeks the TCA BOD will take steps to give updates to the membership, reflecting a positive update on the financial status issue.
